**Re:** Regulations Amendment

Please be advised of the following amendment to the Bowls NSW Regulations as approved by the Board on 13<sup>th</sup> August 2015.

Regulation	Reason for amendment	Details of Amendment
3.1	To facilitate the removal of Multiple Membership	Insert new Regulation 3.1(c) <i>"An Individual Member need only be registered with the Association at one Club to meet the requirements of clause 34.1(b) of the Association Constitution even where they are a member of more than one Club"</i>
3.2	To facilitate the removal of Multi-Membership	Delete Regulation 3.2(ii) & 3.2(iv) relating to Sub Categories Multiple Club Member and Junior Multiple Club Membership.
3.3	To facilitate the transfer of registration of an Individual Member between clubs	Amend Regulation 5.3 to read <i>(a) An Individual Membership of the Association or the benefits of such Membership shall not be transferrable from one Individual Member to another person, Bowling Member or non-Member.</i> <i>(b) An Individual Membership of the Association may, upon completion of the appropriate form and payment of the prescribed fee, be transferred from one Club or Affiliated Sub-Club to another Club or Affiliated Sub-Club.</i>
5.1	To facilitate the removal of Multi-Membership	Insert new Regulation 3.1(d) <i>"A Bowling Member (whether registered as an Individual Member or Registered Player) need only be registered with the Association at one Club to meet the requirements of clause 34.1(b) of the Association Constitution even where they are a member of more than one Club."</i>
5.2	To facilitate the removal of Multi-Membership	Delete Regulation 5.2(ii) & 5.2(iv) relating to Sub Categories Multiple Club Player and Junior Multiple Club Player.

5.3	To facilitate the transfer of registration of a Registered Player between clubs.	<p>Amend Regulation 5.3 to read</p> <p><i>(c) A Player's Registration with the Association or the benefits of such registration shall not be transferrable from one Registered Player to another person, Bowling Member or non-Member.</i></p> <p><i>(d) A Player's Registration with the Association may, upon completion of the appropriate form and payment of the prescribed fee, be transferred from one Club or Affiliated Sub-Club to another Club or Affiliated Sub-Club.</i></p>
7.1	To clarify that a Bowling Member will only be registered at one Club which shall be their Declared Club	<p>Insert new sentence to Regulation 7.1(b);</p> <p><i>(b) An individual may be a member of one or more Clubs however shall only have one Declared Club. An individual shall only be registered with the Association at their Declared Club.</i></p> <p>Insert new Regulation 7.1 (d);</p> <p><i>(d) Where an individual has nominated their Declared Club and has been registered with that Club the requirements of clause 34.1(b) of the Association Constitution will have been met despite that individual being a member of more than one Club.</i></p>
7.2	Name of relevant form changed	Various amendments within Regulation to change 'NSW Club Clearance Form' to 'Clearance and Membership Transfer Form'
